- The website, domain, graphics and any programming code remain the property of Eudemonics until all outstanding accounts are paid in full.
- Any scripts, cgi applications, php scripts, or software (unless specifically agreed) written by Eudemonics remain the copyright of Eudemonics and may only be commercially reproduced or resold with the written permission of Eudemonics.
